ALL THE FOLLOWING TIMES ARE TAKEN FROM COURT DOCUMENTS, STATEMENTS, MESSAGES AND INTERCEPTS. On the 2nd on November, Amanda Knox's own words say "I was in a room for six hours straight" and

"around 9 at night" she was placed in a waiting room where she talked to others and made and received phone calls from friends and family. No mention of being questioned after 9pm. Phone intercept she complains that she wasn't being questioned and was just standing or sitting around while the Police do nothing.

- 15:00 until 21:00 = SIX hours She left the Police station at 05:30 after 15 HOURS TOTAL with Police
- On the 3rd November she returned to the Police station at 11:00. This day she was taken to the cottage. Amanda Knox's own words say "a good five and a half hour day" makes it 17:00 when finished. This is corroborated with phone intercept as she was leaving the station. Afterwards she
- She has spent 21 HOURS TOTAL with Police, most of it in the company of others.
- On the 4th November Amanda was once again at the Police station. She arrived there at 13:30 and was questioned no later than 16:30. After this time she was with other housemates when they were
- brought back again to the cottage. She left the Police station at 20:30. SHE WAS NOT ALONE for the full duration. This was the day she wrote her email home and we have no reason to disbelieve her hourly accounts of the past two days as they are corroborated by phone intercepts and activity.

- BEFORE SHE BLAMED AN INNOCENT AND THERE WERE NO CLAIMS OF PRESSURE BEFORE 00:30
- 53 HOUR INTERROGATION IS A LIE WHICH AMANDA KNOX IS FULLY AWARE IS A LIE. NO 53 HOUR INTERROGATION MEANS NO REASON FOR AMANDA NOT TO KNOW THE TRUTH.
